Information in accordance with Chapter III Section 2 of Regulation (EU) 2016/679 (General Data Protection Regulation; GDPR) on the processing of "cultural offers"

Purpose of collecting personal data

Purpose for which the personal data are processed

As part of the cultural program, we offer students cultural events, courses or workshops on various topics. We use your personal data to organize and implement these cultural offers. Some events are carried out by external cooperation partners commissioned by us. Here we prepare the organization, the cooperation partner carries out the event on his own responsibility. You will be referred to the implementing cooperation partner by us.

Obligation to provide personal data on the part of the person concerned and the possible consequences of not providing it

There is no legal or contractual obligation that you provide us with your data. However, you cannot take part in our cultural program without providing the data.

Passing on the list of participants including contact details to cooperation partners for the implementation of a face-to-face event.

Passing on the list of participants including contact details to cooperation partners for the implementation of an online event. Here we prepare the organization, the cooperation partner carries out the event on his own responsibility. We would like to point out that the cooperation partners may use their own video conference tools.

For some cultural events we use the video conference tool Zoom. This is a program from Zoom Video Communications, Inc., based in the United States. The company's online privacy policy can be found at https://zoom.us/de-de/privacy.html.

Intention to transfer the personal data to a non-EU country

Communication via the video conference tool Zoom is also handled by the company Zoom.us on servers in the USA. When using Zoom, there is consequently a third country transfer. This is based on EU standard contractual clauses.

Rights of the data subject

Status: April 26, 2022

If your personal data is processed, you are a data subject within the meaning of the GDPR and you have the following rights vis-à-vis the person responsible:

the right to information according to Art. 15 GDPR, the right to correction according to Art. 16 GDPR, the right to deletion according to Art. 17 GDPR, the right to restriction of processing according to Art. 18 GDPR, the right to data portability in accordance with Art. 20 GDPR and the right to lodge a complaint with a supervisory authority in accordance with Art. 77 GDPR.
